The Fairfax County (FC) Communities of Trust Committee (COTC) was established in December 2014, to engage the community in identifying, discussing and finding resolutions to concerns and issues with law enforcement. The initial discussion was a result of the unrest in Ferguson, Missouri after the killing of an unarmed Black youth. County leaders met to discuss what is or should be in place to prevent a Ferguson in Fairfax.

This diverse committee includes law enforcement, civic, government and faith based organizations. The COTC has engaged many communities in discussion on how to improve community and law enforcement relationships. COTC has been recognized for its assertive movement in implementing recommendations of the President's Task Force for 21st Century Policing.
